**ENROLLMENT PROCESS**

1. All new students must complete an Enrollment Application and send it with the \$25 enrollment fee to the above address. (Enrollment fee is non-refundable and only enrolls student in the school and does not include individual course tuition fees.) This fee is applicable for up to 3 years of consecutive enrollment.
2. An Administrative Fee of \$25.00 is also required with the enrollment fee and should also be sent to the above address.
3. Upon receipt of application and acceptance into the school, student may register for classes. Tuition must be received at the district office by the stated deadline.
4. Study materials will be provided on the Moodle platform. A link will be emailed to the student upon completion of enrollment.
